Call To Order

The Civil Service Commission met in regular session on Thursday, March 18, 2021 at 11:00 a.m. at 105 N. Main Street (second floor conference room), Washington C.H., Ohio 43160.

Roll Call

The meeting was called to order at 11:00 a.m.

Approval of Minutes

BUSINESS SECTION

1. Police Department: Certify Entry Level Patrolman combined exam

The presented list are the combined results (Chapter 9.01 of the Civil Service Board of Washington Court House Rules and Regulations) from the previous eligibility list certified on 9/17/2020, expiring on 9/17/2021 and the written examination conducted by Public Service Testing Associates, LLC on March 13, 2021, plus military credit.

2. Police Department: Lateral Transfers

Lieutenant Funari presented the board members with a binder of additional lateral transfer information. Funari explained that the binder held information that he gathered from surrounding counties' lateral movement policies. He stated these documents obtained the criteria and rules that the Washington Court House Police Department would like to follow.

Mr. Roszmann inquired on who would be writing these rules.

Police Chief Hottinger stated that there were two options for whom would write the rules. "One, the city attorney would write the rules with Lieutenant Funari and the civil service board could make adjustments. Or option two, the civil service board and Lieutenant Funari write the rules and have the city attorney review them."

Mr. Roszmann stated that there will need to be an application specifically for Lateral Transfer Applicants.

Chief Hottinger explained that the current employment application will be adjusted by Lieutenant Funari, making a separate application for lateral transfers.

The board members agreed to look over the binder of additional information given and continue lateral transfer discussion at the next meeting.

The board members agreed to contact Mr. Pitstick the City of Washington Court House attorney to write new lateral transfer rule.
