Call To Order

BUSINESS SECTION

1. Police Department: Lateral Transfers

The Washington Court House City Council has approved the Civil Service Commission Lateral Transfer Ordinance.

Ordinance No. 4-2021

AN ORDINANCE REQUESTING THE CIVIL SERVICE COMMISSION TO ESTABLISH A PROCESS ALLOWING FOR THE LATERAL TRANSFER OF POLICE OFFICERS AND FIRE FIGHTERS TO THE CITY OF WASHINGTON COURT HOUSE, OHIO FROM OTHER JURISDICTIONS AND AUTHORIZING THE CITY MANAGER TO SELECT CANDIDATES FOR POLICE OFFICER AND OR FIRE FIGHTER FROM THE CURRENT ELIGIBILITY LIST OR FROM A LATERAL TRANSFER LIST.

Fire Chief Tim Downing noted that the Fire Department is included in this ordinance, but at this time the Fire Department does not want to move further with the lateral transfer process. Downing expressed gratitude for his department being included in the ordinance as an option if they ever need to implement lateral transfers in the future.

The Civil Service Commission board agreed to construct and review the writing of the lateral transfer rule for the Police Department, to be added to the current Washington Court House Civil Service Commission Rules and Regulations.

Police Chief Jeff Funari to construct a lateral transfer employment application for the Police Department.

MOTION CARRIED.


